Application is for a land use variance for a Short-Term Rental Complex with 7 Tiny Homes. Also, a setback variance from the required 80' to 37' for the Tiny Home Complex.

Joas Schlabach was present as the petitioner (750 E North Street., Shipshewana). Joas explained the reasoning behind the Tiny Homes idea, the main idea being to help the Community Health Clinic's clients, as most of them are from out of town.

The board discussed Joas rezoning the ½ acre to a B-3 zone to help with setbacks, also to separate home and business.

Joas agreed to withdraw his variance and file for a rezone to the B-3 for the April 11<sup>th</sup> Plan meeting.
