Vernon will have wholesale and retail wet and packaged dog food. There will be 3 phases, phase 2 is residential and they will have 3 full-time employees.

Amber Taylor from Taylor Land Surveying (1240 S 1150 E., LaGrange) was present along with the petitioner John Schmidt.

The site plan was discussed at length by the board.

Lynn Bowen asked for public comment, public comment was closed.

Shannon Schrock made a motion to approve the petition. Zach Holsinger seconded the motion.

A vote was taken, 8 Yes / 0 No / 0 Abstain and the motion carried.

LEHMAN, MERVIN & AMANDA~CFO ~ <u>By. Agronomics/Taylor Land Surveying</u> **(23-SP-46)** Johnson Twp., Sect. 27, T36N R10E, zoned A-1. Located on parcel #44-10-27-200-006.000-010, South of 6070 S 400 E., Wolcottville. Application is for a proposed 56'x540' Herbruck Pullet barn, 42'x48' covered manure storage, 16'x24' office area in barn, 32'x16' concrete pad, 10'x14' motor room and 15'x30' feed bin pad.

Robbie Miller introduced and explained the petition.

Melissa Lehman from Agronomics Solutions (336 E Lake St, Topeka, IN) was present along with the petitioner. Melissa explained the use of the CFO being to house 56,000 chicks for 17 weeks to help with the numerous egg contracts in the area. No berms are required, IDEM did require soil borings. NOI & Rule 5 has been filed with the appropriate offices.

Lynn Bowen asked for public comment in favor of the petition

• Steve McKown spoke about the odors around the lake, he doesn't think the CFO would be much different then what is already there.

Lynn Bowen asked for any remonstrators:

- Carolyn Muller spoke against the petition. Carolyns concern is air quality, home values, lake quality and the site being across from a school (extra traffic). Carolyn stated she had a petition against the petition with 90 signatures.
- Teresa Gust sent a letter to the Plan Commission, Robbie read the letter to the board stating the concerns of waste disposal and preserving the watershed.
- Robert & Laura Berghoff -also sent a letter to the Plan Commission, Robbie Miller read it to the board. Robert & Laura's concerns were the intersection becoming dangerous, the school across the street, manure piling up, lake pollution and water quality testing from Lake Council.

The concerned wrote letters to IDEM about the petition but no appeals were ever made against the CFO. Melissa explained how it will be enclosed, climate controlled with fans and will have trees planted by the fans to control odor. They will be selling manure to surrounding farmers. The board suggested using lime in the sawdust to reduce smell, but the County does not have an ordinance on odor.

Lynn Bowen closed the public comment.

Jim Young made a motion to approve the petition. Ethan Prough seconded the motion.

A vote was taken, 6 Yes / 2 No / 0 Abstain and the motion carried.

COMMUNICATIONS: Robbie spoke about 2024 changes, fee increases.
