FLOOD PLAIN ORDINANCE ~ By. Plan Commission

Robbie Miller introduced and explained the petition, spoke on the updates to the new Flood plan Ordinance.

Section H was the only added section, another update was the home owner would have to choose between ‘best available date’ OR ‘hydrological study to DNR and the DNR determines within 120 days.’

They would have to hire a hydrological engineer to conduct the studies.

By the year 2025 Robbie will need to be a certified Flood Plain Administrator.

The text amendment at the Special Meeting will go to the Commissioners with a recommendation.

Robbie also mentioned a surveyor’s elevations could pull the property out of the flood plain.

Lynn Bowen closed the public hearing.

Zach Holsinger made a motion to send the Text Amendment to the Commissioners with a favorable recommendation, Ethan Prough seconded the motion. A vote was taken, motion carried.

Ethan Prough made a motion to adjourn, Kevin Myers seconded the motion.
