WOODWORTH, TODD & DIANE ~ RIVERDALE WOODS ~ By: <u>Taylor Land Surveying</u> (**20-SB-04**) Newbury Twp., Sect. 28, T37N R8E, zoned A-1. Located North of 9750 W 100 S, Shipshewana. Application is for a one-lot minor plat.

Robbie Miller introduced the petition and reviewed the plat. Mrs. Miller stated that the entire parcel is in a flood plain and that the Subdivision Control Ordinance states that a stem lot should be 50' or can have a 50' easement to the property, not a 25' stem with a 25' easement.

Amber Taylor, Taylor Land Surveying, was present on behalf of the petitioner. Mrs. Taylor explained the plat, stating that the owners wanted the 25' stem with the 25' easement due to tax purposes.

The board discussed the plat and stem lot at length.

Zach Holsinger made a motion to approve the plat pending an updated plat showing either a 50' stem or a 50' easement, Alfredo Garcia seconded the motion. A vote was taken, motion carried. The plat was approved as presented.

The board discussed the plat. Zach Holsinger had questions about the Northern septic system and where it went. Alfredo Garcia stated that the proposed building is sitting on a sewer line.

A vote was taken, motion carried. The site plan will be send to the LaGrange County Plan Commission.
