THE LAGRANGE COUNTY PLAN COMMISSION MET IN REGULAR SESSION ON TUESDAY, JANUARY 14TH, 2025 AT 6:00 PM. IN THE COUNTY OFFICE BUILDING WITH THE FOLLOWING AGENDA:

CALL TO ORDER: Lynn Bowen called the Plan Commission meeting to order at 6:00 p.m.

ELECTION OF OFFICERS: Tyler Young made a motion to nominate Dustin Glick as General Counsel for the Board, Robbie Miller as the Zoning and Flood Plain Administrator, Christa McCormick as the Board Secretary/Administrative Assistant, Kali Baker as the Planning & Zoning Inspector, Kate Kervin as Code Enforcement Official. Ethan Prough seconded the motion.

Tyler Young nominated Lynn Bowen for the County & Town of LaGrange Board of Zoning President. John Reffett seconded the motion.

Tyler Young nominated Lynn Bowen as Plan Commission President. Zach Holsinger seconded the motion.

Lynn Bowen nominated Tyler Young as Plan Commission Vice President. Ethan Prough seconded the motion.

Lynn Bowen motioned to close the nominations. Kevin Myers seconded the motion.

Application is for a proposed Planned Unit Development for 20.75 +/- acres for mixed use of commercial and agricultural to develop lots for future lessee spaces.
