REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, March 3, 2025, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Peter A. Cook and Mr. Kevin R. Myers; and LaGrange County Auditor, Kathryn Hopper. Mr. Terry Martin was absent. Mr. Peter Cook, Vice President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion and it carried unanimously.

PARK - MERCHANT AGREEMENT

Mrs. Mary Franke, Park Director, presented a Merchant Application and Agreement for Point of Sales for the Park Department. Mr. Kevin Myers made a motion to approve the document and authorize the President to sign it outside of a public meeting. Mr. Peter Cook seconded the motion and it carried unanimously.

NUISANCE STATUS UPDATE - 0230 E 500 N, HOWE, INDIANA

Mr. Kurt Bachman, County Attorney, explained that a nuisance existed at 0230 E 500 N, Howe, Indiana, owned by Thomas Tribbett. Mr. Tracy Harker, County Sheriff, reported that there are a few mowers on the property that need to be removed. Mr. Tribbett is waiting on the Indiana Department of Natural Resources on getting permission to install a fence on the property. Fines are accruing on the matter until it is completely cleaned up. Mr. Kevin Myers made a motion to extend the nuisance matter until April 7, 2025, and authorize an order to signed by the President outside of a public meeting. AMERICAN STRUCTUREPOINT, INC. - BRIDGE 49 CONTRACT

Mrs. Tharon Morgan, County Engineer, presented the LPA Consulting Contract between LaGrange County Board of Commissioners and American Structurepoint, Inc. for the replacement of Bridge 49, at County Road 700 South over Westler / Witmer Lake Channel. This is for a grant and the maximum payable under the grant shall not exceed \$26,500. Mr. Peter Cook made a motion to approve the contract. Mr. Kevin Myers seconded the motion and it carried unanimously.

BUTLER, FAIRMAN, AND SEUFERT INC. - PAINT STRIPING CONTRACT

Mrs. Tharon Morgan, County Engineer, presented the LPA Consulting Contract between LaGrange County Board of Commissioners and Butler, Fairman, and Seufert Inc. for striping of unstriped roadways at various locations within LaGrange County. This is for a grant and the maximum payable under the grant shall not exceed \$45,000. Mr. Peter Cook made a motion to approve the contract. Mr. Kevin Myers seconded the motion and it carried unanimously.

She would like to do a chalk walk the week of April 14 to raise awareness. Mr. Kevin Myers made a motion to approve the activities. Mr. Peter Cook seconded the motion and it carried unanimously.

INFORMATION TECHNOLOGY - TELEPHONE SYSTEM
