COUNTY ENGINEER - 2026 ROAD PROJECTS

Mrs. Tharon Morgan, County Engineer, explained that she will be applying for a Community Crossing Grant for a road resurfacing project from the Town of Topeka to county Road 1100 E. The estimate for the project is \$5,399,983.44. The grant would fund \$1,500,000 if awarded. She would need to apply for the grant in March.

Mrs. Morgan would like to improve the intersection of County Road 700 South and State Road 3. The estimated cost of the project is \$231,250. The work would be performed in 2026.
