REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, March 17, 2025, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Peter A. Cook and Mr. Kevin R. Myers; and LaGrange County Auditor, Kathryn Hopper. Mr. Terry Martin was absent. Mr. Peter Cook, Vice President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion and it carried unanimously.

McCOY LITIGATION

Mr. Kurt Bachman, County Attorney, requested authority to enter into a settlement agreement with the McCoy family. Mr. Kevin Myers made a motion to authorize Mr. Bachman to enter into the settlement agreement with the McCoy family. Mr. Peter Cook seconded the motion and it carried unanimously. Mr. Kevin Myers made a motion to authorize any necessary documents to be signed outside of a public meeting. Mr. Peter Cook seconded the motion and it carried unanimously.

PIPELINE PROPERTIES

Mr. Kurt Bachman, County Attorney, requested authority to move forward with the petition on the pipeline properties. Mr. Kevin Myers made a motion to authorize Mr. Bachman to move forward on the petition. Mr. Peter Cook seconded the motion and it carried unanimously.

COMMUNITY CORRECTION GRANT APPLICATION

Mr. Brett Hays, Executive Director of the Northeast Indiana Community Corrections, presented a request to apply for a grant for the Community Correction program for 2026. Mr. Hays informed the Council that the grant application is for funding a full-time probation officer and a Drug Court coordinator for LaGrange County. Mr. Kevin Myers made a motion to approve the grant application as presented. Mr. Peter Cook seconded the motion and it carried unanimously.

ARK ANIMAL SANCTUARY – REQUEST FOR FURNACE PURCHASE

Mr. Tom Tribbett, ARK Animal Sanctuary board member, presented quotes for secondary heat source at the animal shelter. The quote from 24/7 Emergency Services in the amount of \$15,659.86, would work best for the facility. Mr. Kevin Myers made a motion to approve the quote, subject to funding. Mr. Peter Cook seconded the motion and it carried unanimously.

ARK ANIMAL SANCTUARY - PARKING

Mr. Tom Tribbett, ARK Animal Sanctuary board member, explained that they would like to expand the parking area of the facility by spreading limestone in an area. The County Engineer and Highway Supervisor will check with IDEM, since this is near the landfill. Mr. Peter Cook made a motion to table the matter. Mr. Kevin Myers seconded the motion and it carried unanimously.

USE OF COURTHOUSE GROUNDS

Mr. Gary Mast, Maintenance Director, explained that the Church of God would like to use the Courthouse grounds on July 17 and 18, 2025 for a revival and have a bounce house. They would provide proof of insurance prior to the event, naming the County as additional insured. Mr. Kevin Myers made a motion to approve the use of the grounds. Mr. Peter Cook seconded the motion and it carried unanimously.

NIPSCO

Mr. Gary Mast, Maintenance Director, explained that NIPSCO is requesting \$26,212 to update the electrical transformers and meters at the Courthouse. No action was taken at this time.

COUNTY OFFICE BUILDING - SECOND FLOOR

REGULAR SESSION

Mr. Gary Mast, Maintenance Director, presented an estimate from D & S Builders, Inc. for upgrades to the second floor of the County Office Building, in the amount of \$33,400. They would upgrade the ceiling grids, lighting, and restrooms. Mr. Peter Cook made a motion to approve the estimate. Mr. Kevin Myers seconded the motion and it carried unanimously.

AMENDMENT TO THE UNIFIED DEVELOPMENT ORDINANCE

Mrs. Robbie Miller, Plan Administrator, presented the following Ordinance for consideration:

LAGRANGE COUNTY, INDIANA ORDINANCE NO. 2025-03-17 A

AN ORDINANCE AMENDING MAPS OF THE UNIFIED DEVELOPMENT ORDINANCE OF LAGRANGE COUNTY, INDIANA FOR THE PURPOSE OF CHANGING THE ZONING CLASSIFICATION AND USES ALLOWED ON THE PARTICULAR REAL ESTATE DESCRIBED HEREIN

WHEREAS, on August 19, 2024, pursuant to Indiana Code ("IC") 36-7-4-606, the Board of Commissioners of the County of LaGrange ("Commissioners") adopted the Unified Development Ordinance of LaGrange County, Indiana (Ordinance 2024-08-19-A or "UDO");

WHEREAS, the UDO is the zoning ordinance for LaGrange County, Indiana ("County") and incorporates by reference the various zoning maps and classifications of the County;

WHEREAS, pursuant to IC 36-7-4-602(c)(1)(B), after the zoning ordinance for a jurisdiction has been adopted, a proposal to change the zoning maps with respect to a specified area of the County may be initiated by a petition signed by property owners who own at least 50% of the land involved;

WHEREAS, Michael J & Iva J Wingard (collectively, "Landowner") has at least a 50% ownership interest in the real property located at 428 W Lake St., Topeka, Indiana identified as Parcel 44-12-25-400-000.098-008 in the records of the Office of the County Auditor, and more particularly described as follows:

Situated in LaGrange County, State of Indiana, to-wit:

A tract of land located in the Southeast Quarter of Section 25, Township 36 North, Range 08 East, in Eden Civil Township, LaGrange County, the State of Indiana. Said tract being an Original Survey as prepared by Scott D. Zeigler, PS #LS29600008, dba Hand to the Plow Surveying, LLC; 5678 West – 350 South, Albion, Indiana 46701, being represented as Plat of Survey #36-08-25-200-004. Said tract being all of that tract of land conveyed to Michael J. and Iva J. Wingard, as described in LaGrange County Plat Book 27, Page 32, and being more particularly described as follows, to-wit: Lot 2 in the plat of WINGARD SUBDIVISION

(the "Real Estate");

WHEREAS, pursuant to Sections 13.03 and 13.04 of the UDO, Landowner has caused a completed application to be filed with the Zoning Administrator to amend the zoning maps of the UDO such that the Real Estate be reclassified from U-1 to B-2 ("Proposal");

WHEREAS, on March 11th, 2025, pursuant to IC 36-7-4-602(c)(4) and -608(b), after having provided legal notice to all interested parties in accordance with IC 36-7-4-604, the LaGrange County Plan Commission ("Plan Commission") conducted a public hearing on the Proposal;

REGULAR SESSION

WHEREAS, on March 11th, 2025, pursuant to IC 36-7-4-602(c)(5) and IC 36-7-4-605, the Plan Commission submitted to the Commissioners a certified copy of the Proposal, which is hereby incorporated by reference, whereby the Proposal was given a favorable recommendation

WHEREAS, on March 17th, 2025, pursuant to IC 36-7-4-602(c)(6) and IC 36-7-4-608, the Commissioners considered the Proposal at its regular meeting, after first having given notice under IC 5-14-1.5-5 of its intention to consider the Proposal at the meeting;

WHEREAS, pursuant to IC 36-7-4-603, in preparing and considering the Proposal, both the Plan Commission and Commissioners have paid reasonable regard to the statutory criteria set forth therein; and

WHEREAS, a motion to adopt this ordinance was substantively introduced and seconded by members of the Commissioners constituting a legal quorum present at a public meeting, which was duly called pursuant to IC 5-14-1.5-5 by a notice stating its date, time, place, and purpose.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF LAGRANGE, INDIANA, THAT:

SECTION I – MAP AMENDMENT

- A. Recitals. The foregoing recitals, including all defined terms, are hereby incorporated into, and made a part of, this ordinance and found to be true, accurate, and correct.
- B. Proposal. The certified Proposal is hereby approved and adopted.
- C. Rezone. The UDO zoning maps, which are incorporated by reference, are hereby amended, and shall be redrawn as necessary, to show that the Real Estate is rezoned as stated in the Proposal.

SECTION II - MISCELLANEOUS

- A. Repeal of Prior Law. All other provisions of ordinances and resolutions previously adopted are hereby repealed to the extent they are inconsistent with or in conflict with this ordinance but only to such extent.
- B. Conflicts. No part of this ordinance shall be interpreted to conflict with any local, state, or federal laws, and all reasonable efforts should be made to harmonize the same.
- C. Severability. Should any section or part thereof of this ordinance be declared by a court of competent jurisdiction to be invalid, the decision shall not affect the validity of this ordinance as a whole, nor any other portion thereof, and for this purpose the provisions of this ordinance are hereby declared to be severable.
- D. Incorporated Materials. Two (2) copies of all materials incorporated by reference herein shall be on file in the Office of the County Auditor for public inspection.
- E. Promulgation. The County Zoning Administrator and Auditor are hereby authorized, empowered, and directed to take all action necessary or proper to authenticate, record, publish, promulgate, and/or otherwise make this ordinance effective.
- F. Codification. The codifier of ordinances shall omit codification of this ordinance.
- G. Effective Date. This ordinance shall take effect immediately upon adoption.

AN ORDINANCE AMENDING TEXT OF THE UNIFIED DEVELOPMENT ORDINANCE OF LAGRANGE COUNTY, INDIANA FOR THE PURPOSE OF ADDING OR AMENDING CERTAIN REGULATIONS REGARDING DEVELOPMENTAL STANDARDS, USE STANDARDS, AND DEFINITIONS

WHEREAS, on August 19, 2024, pursuant to Indiana Code ("IC") 36-7-4-606, the Board of Commissioners of the County of LaGrange ("Commissioners") adopted the Unified Development Ordinance of LaGrange County, Indiana (Ordinance 2024-08-19-A or "UDO");

WHEREAS, the UDO is the zoning ordinance for LaGrange County, Indiana ("County");

WHEREAS, pursuant to IC 36-7-4-602(b)(1), after the zoning ordinance for a jurisdiction has been adopted, a proposal to amend the text of the UDO may be initiated by the Plan Commission;

WHEREAS, the Proposed Text Amendments to the UDO ("Proposal") are prominently displayed in the Office of the Zoning Administrator for public inspection and is further shown in approximate, unofficial form in Exhibit A, which is attached to this resolution;

WHEREAS, the LaGrange County Plan Commission ("Plan Commission") desires to adopt the stated Proposal, and update the UDO accordingly.

WHEREAS, on March 11, 2025, pursuant to IC 36-7-4-602(b)(4), after having provided legal notice to all interested parties in accordance with IC 36-7-4-604, the Plan Commission conducted a public hearing on the Proposal;

WHEREAS, on March 11, 2025, pursuant to IC 36-7-4-602(b)(5) and IC 36-7-4-605, a copy of the Proposal, which is hereby incorporated by reference, was certified to the Commissioners with a favorable recommendation as to adoption;

WHEREAS, on March 11, 2025, pursuant to IC 36-7-4-602(b)(6) and IC 36-7-4-607, the Commissioners considered the Proposal at its regular meeting, after first having given notice under IC 5-14-1.5-5 of its intention to consider the Proposal at the meeting;

WHEREAS, pursuant to IC 36-7-4-603, in preparing and considering the Proposal, both the Plan Commission and Commissioners have paid reasonable regard to the statutory criteria set forth therein; and

WHEREAS, a motion to adopt this ordinance was substantively introduced and seconded by members of the Commissioners constituting a legal quorum present at a public meeting, which was duly called pursuant to IC 5-14-1.5-5 by a notice stating its date, time, place, and purpose.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF LAGRANGE, INDIANA, THAT:

Mr. Aaron Fugate, Highway Supervisor, reported that he requested requests for proposals for two (2) truck bodies with snowplows. One request was received from W.A. Jones in the amount of \$305,912 for two (2) truck bodies and \$41,916 for two (2) one-way snowplows. Mr. Kevin Myers made a motion to accept the proposal. Mr. Peter Cook seconded the motion and it carried unanimously.

HIGHWAY -TANDEM AXLE TRUCK CHASSIS

Mr. Aaron Fugate, Highway Supervisor, reported that proposals were taken in October 2024 for two tandem axle truck chassis and two truck bodies, blades, and hydraulic components. He was notified by Stoops Freightliner that there will be a tariff charge on the two chassis that were ordered, in the amount of up to \$3,500 for each chassis.

INDOT AGREEMENT - BRIDGE 49

Mr. Kevin Myers made a motion to authorize the president to sign the agreement, retroactive to March 11, 2025. Mr. Peter Cook seconded the motion and it carried unanimously.

COMMUNITY CROSSING GRANT

Mrs. Tharon Morgan, County Engineer, requested approval for the president to sign the Indiana Department of Transportation Community Crossing grant for 2025. Mr. Kevin Myers made a motion to approve the agreement and authorize the President to sign outside of a public meeting. Mr. Peter Cook seconded the motion and it carried unanimously.

CULVERT REPLACEMENT

Mrs. Tharon Morgan, County Engineer, is recommending that Greg Owens Excavating be awarded the quote for culvert replacement for culverts CS 119 and CS 120, in the amounts of \$5,800 and \$3,850 respectively. The culverts are located south of US 20. Mr. Peter Cook made a motion to approve. Mr. Kevin Myers seconded the motion and it carried unanimously.
